Collector Well Progress Report/Email:

RFP Actuator Valves:

Greg Camp went over the very comprehensive report from Jeff Crannick having three bidders that came in with the low bidder being ECO, Inc. in the amount of \$26,930 with a budgeted amount of \$30,000.00. Camp requested a motion to accept the bid from ECO Inc.

RFP Lagoon Pump:

Greg Camp stated we received four bids with a budget of \$15,000. Greg asked Jeff to explain the need for the pump to move water.

Jeff Crannick informed the board that originally those pumps were designed to have the capability to pump water up the hill to the water treatment plant for retreatment. However, since the plant is ground water treatment and



not equipment to treat surface water, they are not going to have to pump water to the plant and will only be pumping water approximately 20-foot head out to the discharge and do not need a big 10 HP pump to do that. A 5 HP pump is adequate for the job. Terry Thomas asked why the 7.5 HP pump is more expensive than a 10 HP pump that was submitted from Vandevanter Engineering? Greg told Terry that they are 2 different manufacturers.

Greg Camp stated that the low bid was from Equipment Pro, Inc. in the amount of \$7,587.13 and entertained a motion.
