AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FESTUS, MISSOURI, REPEALING SECTIONS 150.010 – 150.500 OF THE CODE OF ORDINANCES OF THE CITY OF FESTUS, REGARDING PROCUREMENT; ENACTING A NEW SECTION 150.010 OF THE CODE OF ORDINANCES OF THE CITY OF FESTUS, REGARDING THE CITY’S PROCUREMENT POLICY; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, § 77.260, RSMo provides that the City Council of the City of Festus may enact and ordain any and all ordinances not repugnant to the constitution and laws of this state, and such as they shall be deemed expedient for the good government of the City, the preservation of peace and good order, the benefit of trade and commerce, and the health of the inhabitants thereof; and

WHEREAS, City Staff has reviewed Chapter 150 of the Code of Ordinances of the City of Festus (“Code”) and determined several revisions to the City’s Procurement Policy are necessary; and

WHEREAS, City Staff recommends that Chapter 150 of the Code be repealed, and a new Section 150.010 be enacted to adopt the revised Procurement Policy of the City; and

WHEREAS, the City Council of the City of Festus finds and determines that repealing Chapter 150 of the Code and enacting a new Section 150.010 to adopt a revised Procurement Policy would be in the best interest of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FESTUS, MISSOURI, AS FOLLOWS:

SECTION I. Chapter 150 of the Code of Ordinances of the City of Festus, Missouri, is hereby amended by the enactment of new Section 150.010, to read as follows:

TITLE I. GOVERNMENT CODE.

CHAPTER 150. PROCUREMENT POLICY.

ARTICLE I. GENERALLY.

SECTION 150.010. PROCUREMENT POLICY.

The City of Festus hereby adopts the “Procurement Policy” attached hereto as Exhibit A. A copy of the Procurement Policy shall be kept on file of the office of the City Clerk, and shall be kept available for inspection by the public upon request at all reasonable business hours.

SECTION II. The City's Procurement Policy is incorporated by reference hereto as Exhibit A.

SECTION III. All Ordinances or parts of Ordinances in conflict with this Ordinance are hereby repealed.

SECTION IV. This Ordinance shall be in full force and effect upon its passage by the City Council and the approval by the Mayor.
